This means that all Veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11 will be eligible to enroll directly in VA health care without first applying for VA benefits. Additionally, Veterans who never deployed but were exposed to toxins or hazards while training or on active duty in the United States will also be eligible to enroll.

Did you know the Department of Veterans Affairs (VA) has recognized the alarming rate at which veterans are affected by eczema? Eczema, which is a chronic skin disorder, can be caused by exposure to certain chemicals or environmental factors, and can have a significant impact on a person's quality of life. The new disability benefits will provide financial assistance to veterans who have been diagnosed with eczema as a service-connected disability. This is an important step in recognizing the sacrifices made by our veterans, and providing them with the support they need to manage their condition.

The Federal Government has determined that beneficiaries of Social Security programs will be able to receive this additional payment in December. Additionally, these benefits will be based on the December cost of living adjustment. At their scheduled date, seniors eligible for Supplemental Security Income, Social Security Disability Insurance, and Veterans Affairs benefits, will get the \$2,600 payment.

If you served in the Navy during the Vietnam War, you may have been exposed to Agent Orange.
